## SECTION 4

## FIRST AID MEASURES

### [DESCRIPTIONS]:

- General:** In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.
- Inhalation:** Move individual to fresh air. If individual is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth if possible.

## SECTION 5

## FIRE FIGHTING MEASURES

**General Hazard:** Toxic fumes may be emitted in a fire situation.

**Extinguishing Media:** Foam, dry chemical, carbon dioxide, water spray or fog.

**Hazardous Combustion Products:** Normal combustion forms carbon dioxide, water vapor and may produce oxides of carbon, nitrogen and phosphorous.

**Explosion Hazards:** Dust suspended in air may create a potentially explosive environment.

**Firefighting Procedures:** Evacuate area and fight fire upwind a safe distance to avoid hazardous vapors and decomposition products. Fire exposed containers can build up pressure and should be kept cool with water spray if possible. Explosive vapor could form from ruptured containers. Dike and collect water used to fight fire to prevent environmental damage due to run-off. Foam or dry chemical fire extinguishing systems are preferred to prevent environmental damage from excessive water run-off.

**Firefighting Equipment:** As in any fire, wear self-contained breathing apparatus pressure-demand (MSHA/NIOSH approved or equivalent) and full protective gear.

## ACCIDENTAL RELEASE MEASURES

**Small Spill:** Contain material. Sweep up spilled material which is contaminated and place it and damaged unusable containers in a container appropriate for non-hazardous chemical waste. Check local, state, and federal regulations for proper disposal.

**Large Spill:** Contain material. If material is not contaminated with other materials the product may still be viable for use. ## SECTION 7

## HANDLING AND STORAGE

**Handling:** Wash hands after handling, before eating, drinking, chewing gum, using tobacco, or using the toilet. Avoid contact with eyes and prolonged contact with skin. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

**Storage:** Store in a cool, dry place. Keep containers tightly closed. Store in original container. Do not allow water or other chemicals to be introduced into contents of container. Do not contaminate water sources with equipment wash water, spray disposal wastes or by the cleaning of equipment. Do not store near feed or food products. Do not use or store near open flame or with oxidizing agents, bases, chlorates, or nitrates.

## EXPOSURE CONTROLS/PERSONAL PROTECTION

**Engineering Controls:** When handlers use closed systems, enclosed cabs, or aircraft in a manner that meets the requirements listed in the Worker Protection Standard (WPS) for agricultural pesticides [40 CFR 170.240 (d) (4-6)], the handler PPE requirements may be reduced or modified as specified in the WPS.
